Tim and Peyton finished removing the slide that needed to be taken out. Rob said that the rest of the concrete by the slide needs to come out, Tim will talk to Jeff LeBleu and see if he has some workers that would be able to help get that out. All the electrical in the pool area will need to be replaced. The garage door is in but still at Overhead, they will hold it until we are ready to have it installed. The doors down in the pool area need to be replaced, Tim got a quote for that, and it will be about \$54,000.00 to replace four doors. All the lights in the rec are LED, it costs about \$16.00 a bulb to replace, Tim is looking to see if there are other options. Time and Richard fed May's Construction crew breakfast one morning and a rib dinner the next night. Tim and Richard have put in a lot of time helping with the construction when they needed things. RTU's are up and running, having a couple issues with heating, Trane will be up to look at that. Clark asked if we are on schedule to be done by February 28<sup>th</sup> for the pool? Tim stated yes, but will more know when the pipe is ordered that will give a better time frame.
