All the breaks are under the pool so R&R Aquatics wants to put struts into the foundation so if there is settling in the future that would help. Mays Construction had to remove the diving blocks so some cement work will need to be done for those. Tim asked Natalie to look into what sleeves would cost for the diving blocks. Colorado Doorways will be out Wednesday December 11, 2024, to look at the doors and what it would take to replace them, this includes all doors down in the pool along with the front doors. Christmasfest is underway, the parade was cancelled due to lack of participation. The golf course has about 40 head of elk hanging out there. Currently we are waiting on the materials for the fencing at the golf course then we can have Mike Hayes get that put up. The employee Christmas party in on the 16th and we have three longevity employees that Tim will recognize then.
